Initiating HR's role in building Corporate Governance

Corporate Governance has been known as one of the crucial criteria in evaluating the success of a listed company. Being a Business Partner, HR does play a pivotal role to foster organizational culture and champion different HR initiatives to support the entrenchment of Corporate Governance.

For this sharing session, the speaker will specially talk about how an HR practitioner forms seamless collaboration with the other supporting functions and collectively brings different perspectives and experiences to co-facilitate building Corporate Governance in a local listed company. In a nutshell, the following key points will be highlighted in the discussion:

- HR works hand in hand with the other supporting functions to initiate different programs and activities to sustain the effort of building Corporate Governance across all levels
- HR helps employees acquire appropriate competencies for enabling necessary changes throughout the Organization
- HR faces potential issues in the change process and figures out appropriate resolutions with the engagement of top management
